Eligible and willing candidates in possession of the above qualifications (**not earlier than 2022**) may appear for a walk-in Aptitude/Trade Test on the date and time indicated above at **District Science Centre, Tirunelveli, Kokkirakulam, Tirunelveli - 627 009**. The candidates have to report at the said address by **09.30 AM** for facilitating verification of documents. **Candidates are required to bring their bio-data in prescribed form, which may be downloaded from the website of the Science centre www.dsctirunelveli.org.in under the Careers/Tender Section.**

Candidates are also required to bring their certificates/testimonials in original for verification and Pen, Pencil, Eraser etc at the time of Test. No travelling charges shall be admissible for appearing in the Walk-in-Aptitude Test/Trade Test.

The Candidates who have recently acquired ITI certificate in relevant discipline (not earlier than 2020) should only appear. Candidates with higher qualification and those who have completed traineeship at any units of NCSM are not eligible to apply.

The Candidates are required to submit the following original documents and a set of self attested copies thereof at the time of verification: -

1. Duly filled in application form.
2. Certificates and mark sheets of all educational certificates.
3. Proof of Date of Birth.
4. Photo identity proof of the candidate issued by the Competent Authority of the Govt.

The Candidates who obtain minimum cut off marks in the written test shall only be allowed to appear for the trade test. Selection will be based on the performance in written test & skill test.

No interim enquiries in this regard will be entertained. The competent authority reserves the right to cancel the induction process at any time without assigning any reason whatsoever.

There is absolutely no job guarantee for the trainees after completion of the traineeship period.
